

House Committee Takes First Step to Extend Beer Excise Tax Provisions

On June 20th, the House Ways and Means Committee approved by a 25-17 vote the Taxpayer Certainty and Disaster Tax Relief Act of 2019 (H.R. 3301), to extend through 2020 certain tax provisions that expired at the end of 2017 and 2018, and that will expire at the end of 2019. The package includes a one year extension of the Craft Beverage Modernization and Tax Reform Act provisions that were enacted in the Tax Cuts and Jobs Act of 2017, but expire at the end of 2019. The CBMTRA provisions enacted in 2017 set a tax rate for brewers under 2 million barrels annually at \$3.50/barrel on the first 60,000 barrels of beer produced, and \$16/barrel on any further barrels produced up to 6 million barrels. Above 6 million barrels, the excise tax remained at \$18/ barrel. Proportional reductions in excise taxes were also provided for wineries and distillers.

The next step for the package of tax provision extensions (tax extenders) is uncertain, but will likely require a negotiated agreement, particularly on the issue of whether the cost of the package is offset with spending reductions or tax increases. The package passed by the House Ways & Means Committee is offset by changes to estate tax exemption levels. The Senate has thus far supported passage of tax extenders without requiring offsets.

Gianforte) comes in at #1, followed by Idaho's 2nd district (Rep. Simpson) and North Dakota's at-large district (Rep. Armstrong).

NASS Acreage Reports

2019 barley acreage in the U.S. came in at 2,857,000; up 314,000 acres from 2018, or 12.3.%; and up 307,000 acres from the March Prospective Plantings Report.

2019 acreage estimates for NBGA member states, change from 2018, and March Report:

Colorado at 80,000; up 22,000; a 37.9% increase; up 23,000 from the March Rpt Idaho at 510,000; down 40,000; a 7.3% decrease; but up 45,000 from the March Rpt Maryland at 70,000; up 25,000; a 55.6% increase; up 30,000 from the March Rpt Minnesota at 90,000; up 10,000; a 12.5% increase; up 10,000 from the March Rpt Montana at 880,000; up 90,000; a 11.4% increase; up 70,000 from the March Rpt North Dakota at 620,000; up 150,000; a 31.9% increase; up 90,000 from the March Rpt Washington at 105,000; up 20,000; a 23.5% increase; up 20,000 from the March Rpt Wyoming at 95,000; up 24,000; a 33.8% increase; up 10,000 from the March Rpt
